



SELECTION PROCESS FOR PROFESSOR/RESEARCHER IN THE PELÉ LITTLE PRINCE RESEARCH INSTITUTE AND IN THE POST-GRADUATE PROGRAM IN BIOTECHNOLOGY APPLIED TO CHILD & ADOLESCENT HEALTH (BIOTEC)

NOTICE N° 01/2018

1. PREAMBLE

The Director of Research and Graduate Studies of the FPP publicly announces the rules established to govern the selection process for new professors at the Pelé Little Prince Research Institute and the Graduate Program in Biotechnology Applied to Child & Adolescent Health (BIOTEC).

2. POSITIONS AVAILABLE

There are 2 positions available for 40 hours a week and 2 positions available for 20 hours a week to mentor master's and PhD students.

3. REGISTRATION FOR THE SELECTION PROCESS

3.1 Registration for the selection process for teaching candidates will be completed by submitting the documentation listed in item 3.2 to the Little Prince campus located at Iguaçu Avenue 333, at the *Stricto Sensu* Secretariat, or by email to luciane.favareto@fpp.edu.br, with all documents listed in item 3.2 scanned and attached. This can be done between **March 15, 2018 and May 5, 2018**. Further information can be obtained by emailing luciane.favareto@fpp.edu.br.

3.2 The following documents must be submitted:

- * A letter of intent regarding the applicant's desire to teach in the Program and explaining why the applicant wants to teach in this particular *Stricto Sensu* Graduate Program in Medicine II, within the purview of CAPES. The applicant should describe which of the lines of research, among the 6 listed in the Annex to this Notice, s/he wishes to pursue;
- * A copy of the applicant's identification document and any professional identification;
- * A copy of the applicant's diploma certifying completion of a medical program, or a diploma certifying completion of higher education in a related area;
- * A copy of the applicant's (*Stricto Sensu*) doctoral degree obtained at least 4 years ago;
- * A copy of the applicant's updated Curriculum Vitae.

4. REQUIREMENTS

- 4.1 Leadership experience in research conducted in at least one of the lines of research listed in the Annex to this Notice:
- 4.2 At least 25 publications, the majority of which must have been **published** in Medicine II journals included in the QUALIS listing (available at the CAPES portal on the Sucupira Platform) consisting of articles A1, A2, and B1, with at





least 400 points over the last 4 years (2014–2017) in articles A1, A2, and B1 of QUALIS Medicine II.

5. THE SELECTION PROCESS

Confirmation of the first round of successful applicants will be announced on May 5, 2018 on the site www.fpp.edu.br.

For approved candidates, the first phase of the selection process will consist of review and scoring of the applicant's Curriculum Vitae in anticipation of the second phase, which will be announced on May 16, 2018.

The second phase will consist of a selection interview on May 24 and 25, 2018.

6. RESULTS

The final results will be announced on May 30, 2018, after 2:00 PM, on the site www.fpp.edu.br.

7. GENERAL PROVISIONS

Any omissions or unforeseen circumstances not provided for in this Notice will be resolved by the Director of Graduate Research.
